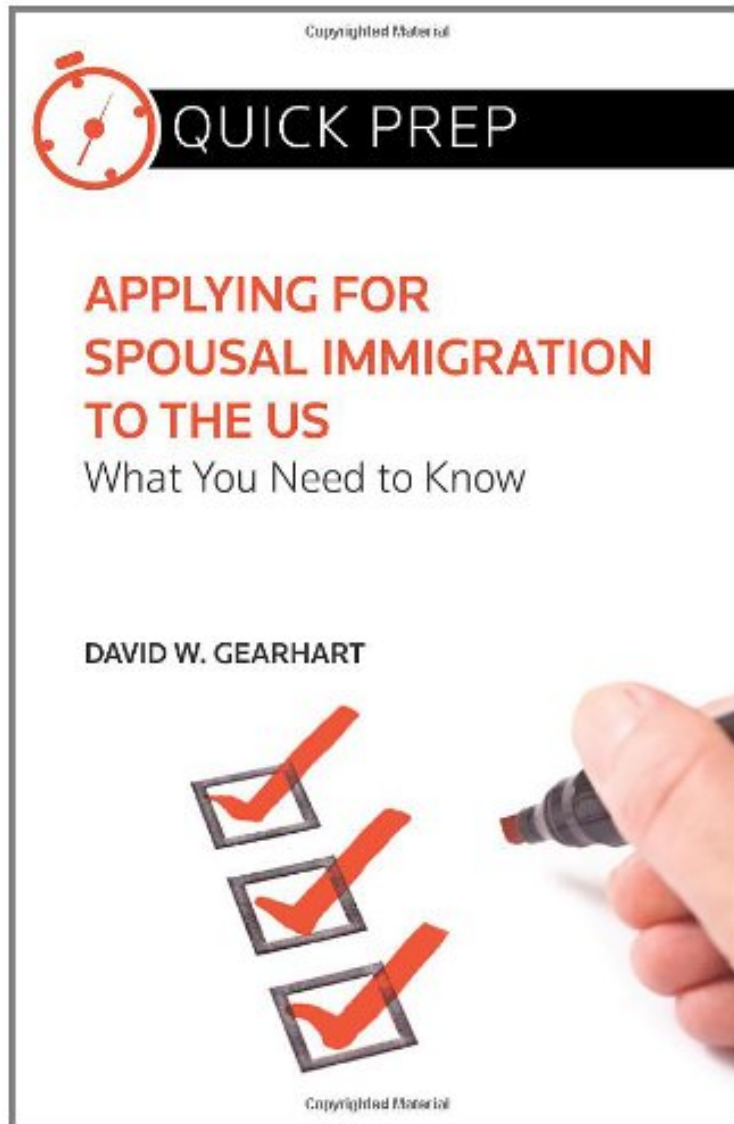

that said, the book does a poor job of explaining the procedures to follow (and forms to file) for each scenario. So after reading the book, I have a good general understanding of what all the forms mean, but am still confused as to which forms and procedures apply to my situation specifically. There is an error in organizing the structure of the book -- it should be organized in scenarios (there are only 4 to 5 in total, so it should be easily doable).
